Jennifer Lampert shared concerns about classroom size and 4th grade students moving to the Middle School. Chris Hasenour asked questions about how the new funds are funded and what expenses are paid for out of each fund. He also had concerns of class sizes and used testing scores as an example. Ashley Seger had concerns about free and reduced applications being promoted in a positive way and if 4th grade moves to the Middle School will it be a contained classroom. Butch Bonifer questioned the Preschool advertising being so small compared to other schools.

Concerns about the 4th grade moving to the Middle School, Celestine Elementary and class sizes were noted and taken under consideration. Free and reduced applications are readily promoted but will take positive aspect under advisement. The Education Fund is funded by the State and the Operations Fund is funded by local tax dollars.
